**Clerks Report on Candidate Compliance Reporting  
 Within Section 88.23 (4) and (5) of the Municipal Elections Act, 1996**

In accordance with the requirements as set out in the Municipal Elections Act, 1996 (“MEA”), with respect to post-election compliance audit review and reporting, I advise of the following:

Under Section 88.23(4) of the MEA, “the Clerk shall make available to the public a report setting out all candidates in an election and indicating whether each candidate complied with Section 88.25”, being the MEA requirements to file financial statements in the prescribed form within a specified time frame.

- The financial statements for each Council candidate for the 2022 Municipal Elections in King Township were filed and received by the Clerk by the filing deadline of March 31<sup>st</sup>, 2023. There were no applications made to the Superior Court of Justice to extend the time for filing of a financial statement, thereby enacting a supplementary filing deadline.
- The financial statements for each York Region District School Board Trustee for the Township of King and City of Vaughan (Ward 1), for the 2022 Municipal Elections in King Township were filed and received by the Clerk by the filing deadline of March 31<sup>st</sup>, 2023. There were no applications made to the Superior Court of Justice to extend the time for filing of a financial statement, thereby enacting a supplementary filing deadline.

Tables A and B below identify the dates on which each candidate, including any candidates who withdrew their nomination, filed their financial statement with the Township of King.

#### Review of Contributions – by Clerk

Section 88.34(1) of the Municipal Elections Act also states that “the Clerk shall review the contributions reported on the financial statements submitted by a candidate under section 88.25 to determine whether any contributor appears to have exceeded any of the contribution limits as specified under section 88.9”, as noted below:

**88.9(1):** “A contributor shall not make contributions exceeding a total of \$1,200 to any one candidate in an election.”

- The review of all financial statements was completed prior to the March 31<sup>st</sup>, 2023 deadline, and no contributors exceeded the contribution limit to any one candidate in the 2022 Municipal Election.

**88.9(4):** “A contributor shall not make contributions exceeding a total of \$5,000 to two or more candidates for office on the same council or local board. “

- The review of all financial statements was completed prior to the March 31<sup>st</sup>, 2023 deadline, and no contributors exceeded the contribution limit to two or more candidates in the 2022 Municipal Election.

**88.9.1 (1):** “A candidate for an office on a council and his or her spouse shall not make contributions to the candidate’s own election campaign that, combined, exceed an amount equal to the lesser of,

(a) the amount calculated by adding,

(i) in the case of a candidate for the office of head of council of a municipality, \$7,500 plus 20 cents for each elector entitled to vote for the office, or

(ii) in the case of a candidate for an office on a council of a municipality other than the office of head of council, \$5,000 plus 20 cents for each elector entitled to vote for the office; and

(b) \$25,000.

- The review of all financial statements was completed prior to the March 31<sup>st</sup>, 2023 deadline, and no candidate and his or her spouse made contributions to the candidate’s own campaign that, combined, exceeded the limits as set out in 88.9.1(1) above.

The Township of King did not receive any registered Third Party Advertisers for the 2022 Municipal Election.
